CECIL COUNTY CHRISTMAS PARADE

REGULATIONS TO PARTICIPATE and DIRECTIONS TO THE STAGING AREA

ARRIVE BY: 11:00 a.m. BUT NOT before 10:00 a.m. **Please DO NOT ARRIVE LATE!!!!!!**

PARADE PARTICIPANTS: **ALL FLOATS AND PARADE PARTICIPANTS (EXCLUDING FIRE EQUIPMENT, SHRINERS AND EQUESTRIAN UNITS)** SHALL enter the parade lineup from **RED TOAD ROAD** (see page 3). **ABSOLUTELY NO EXCEPTIONS!**

FIRE EQUIPMENT: Please enter the Town of North East from Rt. 272. You will be staged on North Main Street.

EQUESTRIAN UNITS ONLY: Please enter the Town of North East from Rt. 272. You will be directed to line up along Race Street by a police officer/volunteer. **No cars will be allowed to drop off participants on Race Street.**

SHRINERS: The Shriners will be contacted by the Parade Committee for staging information prior to parade day.

MARCHING UNITS: Due to limited space, please arrange to car pool to drop off participants. Carpooling cars will be allowed to only stop long enough to drop off participants and must leave staging area immediately. Please have your child dressed in their costume and ready to go. Thank you in advance for your cooperation.

SIZE OF FLOATS: All floats including the tow vehicles may not be higher than 11 feet, wider than 12 feet and must be able to make a 90 degree corner within two traffic lanes. Length of float including the tow vehicle may not exceed 60 feet without prior approval. All floats must use fire retardant materials and carry a fire extinguisher. All floats must have handholds or barriers to secure riders in case of sudden stops or non-smooth movement. Vehicle and float drivers must be able to have a clear view from the front of the vehicle at all times.

SAFETY: Due to the increased number of the spectators and to assure a safe environment for the parade participants and spectators, no candy, gum or distribution of gifts, etc. is permitted by anyone walking, riding or participating in the parade! *Thank you in advance for your cooperation.*

PARADE ROUTE: West Cecil Avenue to South Main Street to Walnut Street. Vehicles will be directed to exit parade route by the police officer via Mauldin Avenue. Marching units will be directed down Walnut Street into the North East Community Park so they may be picked up. Vehicles will exit the park via Cherry Street.

LINEUP: Placement in the parade will be assigned by a Committee member on parade day upon arrival. Please do not contact the Town Hall prior to the parade to try to obtain this information. Due to parade participants that need to withdrawal last minute final adjustments are made the morning of the parade. *Thank you in advance for your cooperation and understanding.*

DELAYS: ANY ONE WHO DELAYS THE PARADE BY STOPPING IN FRONT OF THE REVIEWING STAND LONGER THAN 90 SECONDS WILL BE AUTOMATICALLY DISQUALIFIED AND WILL NOT BE INVITED BACK! WHEN THE WHISTLE SOUNDS, PLEASE MOVE ON! THE JUDGES DECISION WILL BE FINAL.

REVIEW STAND: Judges Review Stand is at 106 South Main Street (North East Town Hall).

AWARDS/PRIZES: Winners will be listed on www.northeastmd.org. Prizes will be mailed to each winner by December 31st.

GENERAL:

1. The Committee has arranged for Santa Claus who will appear at the end of the parade. **No one may have a Santa in their entry – please do not confuse the children with another Santa!** Thank you in advance for your cooperation.
2. To aid the judges, please have some way of identifying your unit or car – a sign, banner, etc. Do not forget to identify yourself from both sides of Main Street. Antique/Modified vehicles please have the model and year of your vehicle on both side windows. Parade units can compete in only one category. Each unit will be judged on its overall presentation.
3. All cars, trucks, and other motorized vehicles must be driven by licensed, insured drivers.
4. Horses, dogs, cows, reptiles and any other wild or domestic animals shall not be in the parade without being identified on the Parade application.
5. No soliciting or advertising for membership of organizations is permitted on floats, signs, vehicles, etc.
6. All applicants must return the application with a signature.
7. All entries must stay 25-30 feet (3 car lengths) behind the entry in front of you. Please do not bunch up or allow a large gap to form in front of you.
8. You may not park in the staging area unless your vehicle is to be driven in the parade.
9. The Parade Committee will be wearing orange reflective vests – please follow their directions!
10. Entries depicting violence, drugs, illicit or illegal activities and otherwise inappropriate for a family audience, will be disqualified and not be allowed in the parade.
11. Parade participants' cars, buses, and vehicles may park at the North East Community Park after dropping off participants at their assigned locations. Fire Police will be in the park to assist parking.
12. **If you are completing this application on behalf of an organization or group, please make sure all members of the organization or group receive a copy of the Regulations and Directions.**
13. Cancellation: If the weather prevents the parade, notice will be given on the answering machine at 410-287-5801 and at www.northeastmd.org.
14. The Parade Committee reserves the right to refuse entry into the Parade of any unit that violates the Regulations aforementioned in the Application Package.
15. Inclement weather date is **December 9, 2017 at Noon.**

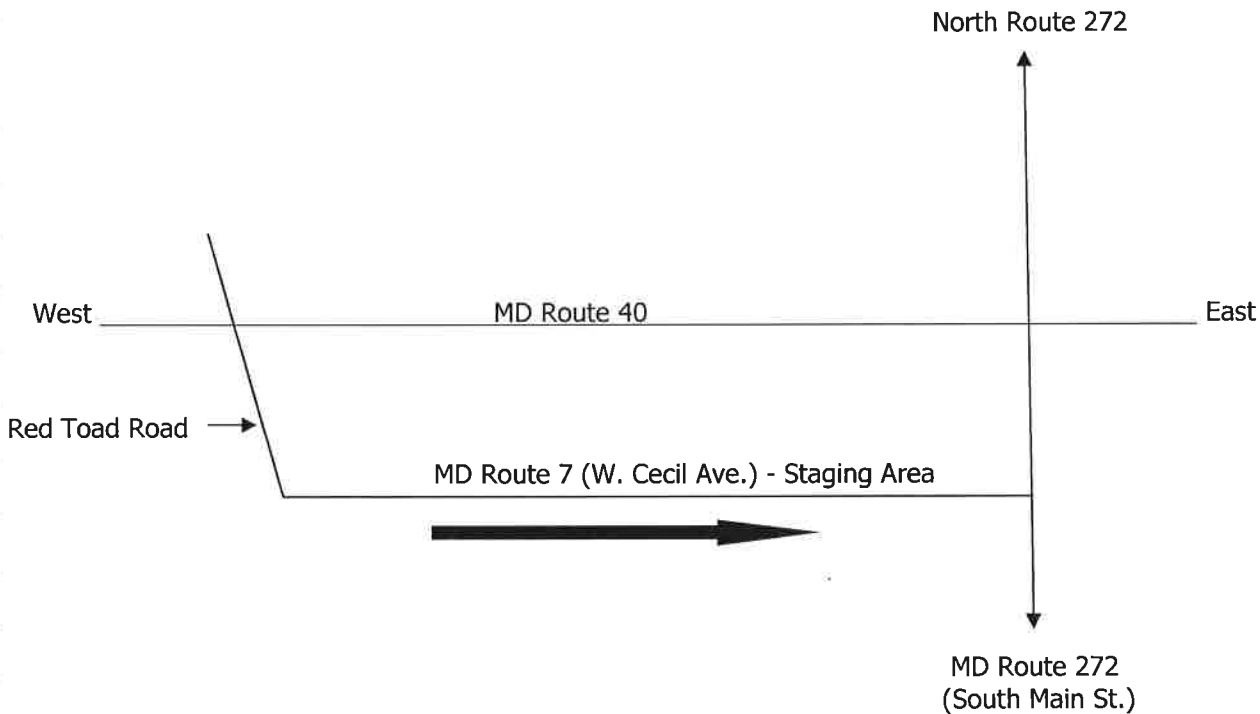
DIRECTIONS TO PARADE STAGING AREA

Eastbound Rt. 40 - make right hand turn onto Red Toad Road (at red light), proceed through two stop signs, make left onto Rt. 7, follow to parade staging area (3/4 mile).

Westbound Rt. 40 - make left hand turn onto Red Toad Road (at red light), proceed through two stop signs, make left onto Rt. 7, follow to parade staging area (3/4 mile).

Northbound I-95 - to Exit 100, Rt. 272 North East, Maryland. Proceed south on Rt. 272 to the intersection of Rt. 272 and Rt. 40 (Wal-Mart will be on your right). Turn right at the Rt. 272/40 traffic light. Proceed westbound and turn left onto Red Toad Road (at red light). Proceed through two stop signs, make left onto Rt. 7, follow to parade staging area (3/4 mile).

Southbound I-95 - to Exit 100, Rt. 272 North East, Maryland. Proceed south on Rt. 272 to the intersection of Rt. 272 and Rt. 40 (Wal-Mart will be on your right). Turn right at the Rt. 272/40 traffic light. Proceed westbound and turn left onto Red Toad Road (at red light). Proceed through two stop signs, make left onto Rt. 7, follow to parade staging area (3/4 mile).



Note: ALL FLOATS AND PARADE PARTICIPANTS (EXCEPT FIRE EQUIPMENT, SHRINERS, AND EQUESTRIAN UNITS) MUST USE THE STAGING DIRECTIONS AS STATED ABOVE. NO ENTRIES WILL HAVE ACCESS TO THE PARADE VIA RACE STREET. ABSOLUTELY NO EXCEPTIONS!

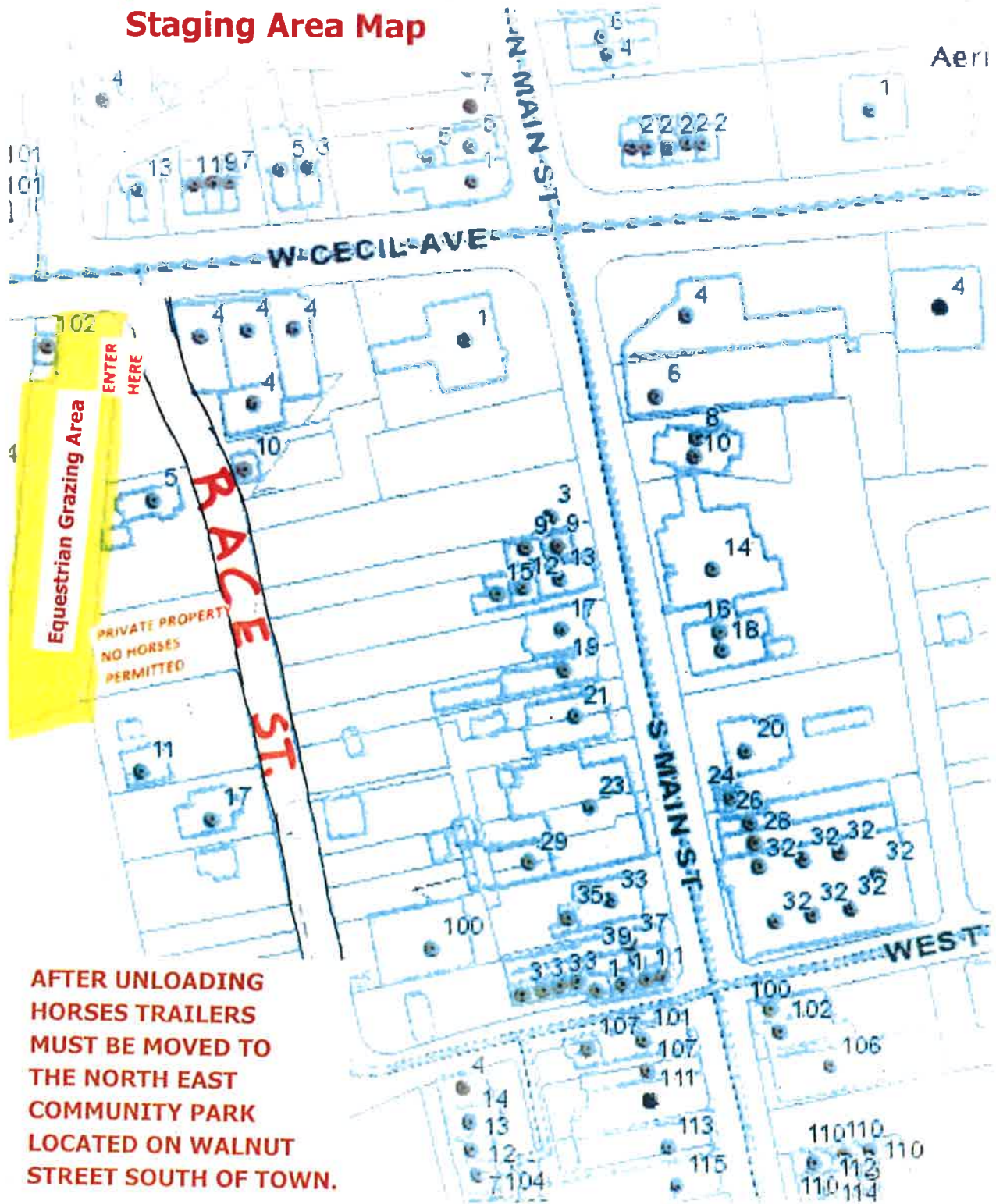
